APRIL 3, 2024

The meeting opened at 7:00 p.m. with the Pledge of Allegiance. Board present were Pat Coultres, Lori Bush, Vern Kassuba, Tom Kellogg and Debbie Whitman.

Treasurer's Report given by Bush showing balances for the month of March as follows: general fund \$525,611.44 and tax collection \$13,904.19. Motion by Coultres, with support by Kellogg, to approve the minutes, bills and acknowledge the Treasurer's report. Roll call vote: Coultres – yes, Bush – yes, Kassuba – yes, Whitman – yes, Kellogg – yes.

PUBLIC COMMENTS: No comments offered.

REPORT FROM COUNTY COMMISSIONER: Commissioner Turnbull reported that next Tuesday's Board of Commissioners meeting will be held at the Alpine Center. Three bids for the new court building were received, still evaluating location. Board of Health meeting approved \$50,000 grant for RISE.

Land Division 042-036-300-005-05 (Coats) Motion by Kassuba, with support by Coultres, to recommend approval. Motion carried, 5-0.

CEMETERY: Nothing to report.

TWP PROPERTY: Fire Department will be installing a washer for turnout gear – Kassuba contacted the plumber for hookup.

WASTE TRANSFER: Clean Up Day April 20, 2024.

FIRE/RESCUE: Raised wages after many years of staying the same.

SCHOOL: Current revenues are at 53.51% of the original budgeted amount for the year and expenditures are running at 53.51%.

PLANNING COMMISSION/PARKS & REC: Kellogg reviewed minutes of March 25, 2024 meetings. 4/17/2024 Coffee meeting to be held at the Township Hall brainstorming on businesses for Corwith Township. Need for land banks discussed at the Planning meeting. Reviewing Article 8 FR District.

ROADS: Cost Share Agreement for Sturgeon Valley Road presented. Motion by Whitman, with support by Kassuba, to approve the Project cost share agreement with the OCRC for Sturgeon Valley Rehabilitation project with the March 15, 2024 email from Kirk outlining approaches and shoulder widening to be included with this project. Motion carried, 5-0.

2023-2024 4th Quarter Budget Report: Motion by Kassuba to transfer \$170 from 101-253-890 to 101-253-703 supported by Bush. Kassuba – yes, Bush – yes, Kellogg – yes, Coultres – yes, Whitman – yes.
